In providing a foster home for one or more dogs belonging to Fetchin' Retrievers Rescue (FRR) I agree to the following:

\_\_\_\_\_ 1. I understand that being a foster is not the same as adopting a dog and I agree to make the dog available to meet potential adopters at a mutually convenient time and place when requested by the dog's representative.

\_\_\_\_\_ 2. I understand that FRR has rescued dogs whose complete history is not always known and who may be anxious, frightened or unpredictable due to a change in their circumstances. I agree to always treat the dogs with compassion and to safeguard myself and others as we interact with the dogs.

\_\_\_\_\_ 3. I promise to provide proper care and attention to the dog that I am fostering. I understand this includes providing food, water and shelter and including the dog in our family routines as much as possible. My role as a foster is to learn more about the dog's temperament and behaviors, nurture good social skills and prepare the dog for life as a family companion in a forever home.

\_\_\_\_\_ 4. I agree to share information, anecdotes and photographs with the dog's representative on a regular basis to help FRR make the best match possible for the dog.

\_\_\_\_\_ 5. I understand that the dog's safety is paramount and promise to keep the dog contained in my home or fenced yard. When outside of my home and yard, I promise to keep the dog on leash at all times and not to visit off-leash dog parks or beaches. I will not allow the dog to become a public nuisance or to run free with unfamiliar dogs who are off-leash and who may act aggressively.

\_\_\_\_\_ 6. I agree to inform the dog's representative of any illness or injury and to collaborate with the representative in determining the best course of action, which may include taking the dog to a veterinarian specified by FRR.

\_\_\_\_\_ 7. When transporting the dog in a vehicle, I will always use a crate or tether the dog to protect both the dog and driver in case of an accident.

\_\_\_\_\_ 8. I agree to take all reasonable precautions and to safeguard myself and others from possible unpredictable actions by the dog and to immediately report any bite incidents involving people or other animals to the dog's representative.

\_\_\_\_\_ 9. I understand that the dog's representative will give me as much information as is known about each dog I foster and I agree to ask questions or raise any concerns during the briefing.

\_\_\_\_\_ 10. I agree to hold harmless and indemnify FRR, its Board of Directors, Officers, Volunteers and Agents from all claims, demands, actions, causes of action or any liability which may arise as a result of providing foster care under this agreement.

\_\_\_\_\_ 11. I will not introduce another resident dog into the house while fostering a dog for FRR without first notifying FRR to discuss any potential health and safety concerns that could arise.
